
BUY BACK RULES

Some PSA Facts

- 1. On 1st November, 2019, PSA had a total of 5856 members and 5361 of those members were individuals.
- 2.36.9% of PSA's members are outside North America.
- 3. Worldwide, 474 clubs are members of PSA.
- 4. A total of 128 PSA members have a portfolio distinction (56 Bronze, 52 Silver and 20 Gold).
- 5. A total of 958 members have a ROPA distinction (143 QPSA, 329 PPSA, 231 EPSA, 143 MPSA, 25 MPSA2, 63 GMPSA, 12 GMPSA/B, 6 GMPSA/S, 3 GMPSA/G, 3 GMPSA/P).
- 6. Outside the USA there are now seven countries with more than 100 PSA members (China 369, India 237, Canada 192, England 167, Australia 164, Hong Kong 127, Indonesia 103).

PSA BOARD NEWS

The PSA Board had several meetings before and during the conference, including a lengthy meeting that focused on strategic planning. There was considerable discussion around issues related to the international exhibitions that receive PSA recognition. The Board reaffirmed that PSA will not be changing its policy on the maximum acceptance rates in exhibitions, it will remain at 35%. However, all members entering international exhibitions need to be aware that when an exhibition has patronage from FIAP the maximum acceptance rate will be 25% (even when the exhibition is recognised by PSA). PSA is working collaboratively with FIAP on several other issues and has signed a Memorandum of Understanding about the joint goals to be achieved. The Exhibition Services VP, Brian Magor, is assisting Exhibition Standards Directors to more closely monitor exhibitions to ensure compliance with all aspects of the Exhibition Standards.



VOLUNTEERS NEEDED

Part of this procedure is the mechanism for lodging complaints about exhibitions via the PSA website. PSA has signed a contract for the development of a new PSA website and membership database. This is a very large undertaking so it will be 12 to 18 months before the new system is fully operational. The Board approved a new policy on the use of drones in photography - see details later in this newsletter.

EXHIBITION STANDARDS DIRECTOR FOR REGION - 7 BRITISH ISLES

The Exhibition Standards Director (ESD) for the British Isles is Andy S Hayes. The area covered is England, Scotland, Wales, Northern Ireland, Ireland, Isle of Mann and the Channel Islands. The duties are to check all applications (excluding 3D) for PSA recognition from any exhibitions in the British Isles seeking PSA recognition and issuing the Certificate of PSA Recognition. Thereafter the ESD monitors the exhibition and website to see that it complies with the conditions of entry as applied for by the exhibition / salon.

DRONE POLICY

The Board approved a new policy on the use of drones and it is available here https://psa-photo.org/index.php?psa-policies&a=view&faq_id=1632. The policy has a legal section which basically requires members to follow whatever laws exist in the country in which they are using a drone. There is also an ethical component to the policy and it states:

One of the tenets of photography, is that the safety and well-being of the subject, photographer and surroundings is of paramount importance over the capturing of the photograph. The purpose of this section is to prevent any interference with other individuals or animals which will or may cause a disturbance in their normal activity or disrupt the way an individual or animal interacts with its environment.

- 1. May not fly a drone above people for the purpose of photographing their activity, unless permission is granted in writing.
- 2. May not fly or photograph animals in their natural habitat, especially nesting areas and locations where the animal is already under stress (winter survival, migratory feeding, protecting young). Photographing scenery/landscapes is permissible.
- 3. May not fly or photograph in any designated wilderness area

DISTINCTIONS

Many people are interested in furthering their photographic skills and obtaining distinctions. There are several routes that can be taken and I'm aiming to give a short introduction which I will follow up in subsequent newsletters. Many of these distinctions require you to be a member of an organisation such PSA, RPS or access is gained through your club and federation membership, PAGB and FIAP. I don't intend to detail everything in this newsletter as there is a great deal of comprehensive information on the relevant organisations websites which I will detail below.

Anyone interested in the PSA system and would like to discuss the way forward please feel free to contact me for any assistance. I have a number of pieces of information that I can email to you to help understand the process.

The PSA distinctions are called Recognition of Photographic Achievement Awards (ROPA) and they consist of QPSA, PPSA, EPSA, MPSA, MPSA2, GMPSA, GMPSA/b, GMPSA/s, GMPSA/g and GMPSA/p.
