Some PSA Facts

- 1. On 30th June, 2019, PSA had a total of 5822 members and 5320 were individuals.
- 2.37% of PSA's members are outside North America.
- 3.59% of PSA's members joined in the last 5 years.
- 4.81% of PSA's members joined in the last 10 years.
- 5.3% of PSA's members joined more than 50 years ago.
- 6.PSA has only 7 Youth members.
- 7.PSA has members in 85 countries.
- 8. Outside the USA there are 6 countries with more than 100 PSA members: China (380), India (253), Canada (196), England (164), Australia (153) and Hong Kong (126).
- 9. Outside the USA there are another 5 countries with more than 50 PSA members: Indonesia (83), Belgium (81), Germany (81), Singapore (80) and Taiwan (63).

10.17% of PSA's individual members have a ROPA distinction: QPSA (135), PPSA (312), EPSA (219), MPSA (140), MPSA2 (20), GMPSA (58), GMPSA/B (15), GMPSA/S (4), GMPSA/G (3) and GMPSA/P (2).

Rule Changes for Image Titles

In April 2018 the Board of Directors changed the rules regarding the titles of color and monochrome images derived from the same image capture. The new rules apply to images entered in PSA recognised exhibitions with closing dates after 1 August 2018.

The new rules were explained in a PSA Journal article in June 2018 and were incorporated into the Stars 1-5 Applications Instruction's and the Galaxy/Diamond Applications Instructions that are available on this page of the PSA website https://psa-photo.org/index.php?stars-and-ropa.

In the August 2018 PSA fournal there was a further announcement that the new rules would also apply to "all images used in any PSA competition or activity" (not just to images entered in PSA recognised international exhibitions).

The rules regarding image titles are given in detail in the Stars/ Galaxies applications instructions and all members are encouraged to read the latest version of those rules. In summary the rules are:

Each different image entered in a PSA recognised exhibition must have a unique title.

A projected image and a print of the same image must have the same title.

A color version of a data capture and a monochrome version of the same data capture are considered to be the same image and both versions must be given the same title.

Once an image has been accepted in a PSA recognised exhibition it cannot be retitled for entry into another PSA recognised exhibition.

When giving titles to your images and entering them in exhibitions please keep the following points in mind:

• Titles such as "Utah landscape" and "Utah landscape BW" are NOT the same – if these are a color and a monochrome version of the same image then both versions should be called "Utah landscape".

EXHIBITION STANDARDS DIRECTOR FOR REGION - 7 BRITISH ISLES

I am please to announce that in June I was appointed as Exhibition Standards Director (ESD) for the British Isles. The area covered is England, Scotland, Wales, Northern Ireland, Ireland, Isle of Mann and the Channel Islands. The duties are to check all applications (excluding 3D) for PSA recognition from any exhibitions in the British Isles seeking PSA recognition and issuing the Certificate of PSA Recognition. Thereafter the ESD monitors the exhibition and website to see that it complies with the conditions of entry as applied for by the exhibition / salon.

• Titles such as "Angry lion" and "Angry lion 2" are NOT the same - if these are a color and a monochrome version of the same image then both versions should be called "Angry lion".

•Both the color and mono versions of an image (with the same title) can be entered in competitions (in any Division or Class) if the applicable rules for the competition are met. For example: If you have an image that fits the Nature definition you might want to produce both a color and monochrome version of that image. Both images would have the same title (e.g. "Eagle in flight"). You could enter either version of the image in any Nature competition (as a print or as a digital image). The acceptances for both the color and mono versions could be used on Star/Galaxy applications in Nature Division. You could also enter the color version in a PIDC competition and the mono version in a PIDM competition. All acceptances gained in PIDC and PIDM competitions could be used on relevant Star/ Galaxy applications. You could also enter the color and monochrome versions of the image in pictorial print exhibitions (large or small) and use those acceptances on relevant Star or Galaxy applications. In all cases, the image would have the same title.

If you had a color and a monochrome version of an image (with different titles) accepted in PSA recognised exhibitions with closing dates before 1 August 2018 all those acceptances remain valid (subject to them meeting the normal rules). If you wish to continue entering those images there are two possibilities:

For purposes of Star ratings you may continue to enter either the colour version or the monochrome version of the image (with its original title).

For purposes of Galaxy or Diamond ratings you may continue to enter both versions of the image (with their original different titles) so that you can complete Galaxy or Diamond title sets for which you had some acceptances prior to 1 August 2018. However, you need to be aware that doing so may expose you to sanctions by FIAP if you enter the images in exhibitions with FIAP patronage.

DISTINCTIONS

Many people are interested in furthering their photographic skills and obtaining distinctions. There are several routes that can be taken and I'm aiming to give a short introduction which I will follow up in subsequent newsletters. Many of these distinctions require you to be a member of an organisation such PSA, RPS or access is gained through your club and federation membership, PAGB and FIAP. I don't intend to detail everything in this newsletter as there is a great deal of comprehensive information on the relevant organisations websites which I will detail below.

Anyone interested in the PSA system and would like to discuss the way forward please feel free to contact me for any assistance. I have a number of pieces of information that I can email to you to help understand the process.

The PSA distinctions are called Recognition of Photographic Achievement Awards (ROPA) and they consist of QPSA, PPSA, EPSA, MPSA, MPSA2, GMPSA, GMPSA/b, GMPSA/s, GMPSA/g and GMPSA/p.
